Professional Development (Most Recent Three Years)

All training and curriculum development activities at Carlton Hills School revolve around the Common Core State Standards for English/language arts and mathematics and the use of technology to enhance the student learning experience. Decisions concerning selection of staff development activities are performed by the principal, district administrators, and grade level representatives using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Carlton Hills School offers support to new and veteran teachers through peer coaching and mentoring. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job related training from department supervisors and district representatives.
