School Safety Plan (School Year 2017-18)

The Comprehensive School Site Safety Plan was developed for Carlton Oaks School in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Professional Development (Most Recent Three Years)

All training and curriculum development activities at Carlton Oaks School support the implementation of Common Core Content Standards and State curricular frameworks. Teachers annually receive between 3 - 5 days of professional development at the site and/or district level. Decisions concerning selection of staff development activities are performed by the principal, district administrators, and grade level representatives using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Carlton Oaks School offers support to new and veteran teachers through peer coaching and mentoring. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job related training from department supervisors and district representatives.
